S.O.....In exercise of the powers conferred by sub-section(2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, due to change in name of affiliating University namely:-

In the said First Schedule before "H.N.B. Garhwal University, Uttaranchal" and entries thereto against "HIHT University" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-
