It is to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty, clinical material and stipend to PG students similar to PG students of government colleges in the state etc. throughout the academic year, as stipulated in regulation of National Medical Commission (NMC).

3. In case of false/wrong declaration or fabricated documents have been used for procuring permissions of MARB and any misconduct is brought to the notice of National Medical Commission (NMC) or found during surprise assessment at any stage during

the current academic year, your institution is liable, not to be considered for recognition of that degree. This letter of permission will be revoked for the current academic year if such exigency arises.

4. Besides, National Medical Commission (NMC) is entitled to take all such measure against you and your college/institution as permissible under the law.

5. It is mandatory to develop a website of medical college/institution and display all the information of college, courses offered faculty available and their experience of last 5 years, students joined, and affiliating university to display the hospital services, facilities available and the equipment in each specialty, also showing OP and IP census including births and deaths as per the Municipal/Government records.

6. It is inform that Bank Guarantee (BG) is essential element for issuance of LoP and is obligatory on the part of medical institutions to submit the same immediately after receiving the LoP/LoI. In view of this, college is requested to furnish the requisite Bank Guarantee (BG) within 15 days of receipt of this letter.

7. In case college does not agree with the above decision of 1st Appeal Committee of NMC, it may prefer an appeal under section 28(6) of NMC Act, 2019 addressed to Additional Secretary (ME), MOHFW, Kartavya Bhawan within 30 days of receipt of this order.
